- The scoring will focus on: the amount of activities, the number of youngsters involved in the activities, the level of professionalism and the type and amount of activities in the past 12 months (i.e. contacts with organisations doing research on a professional level e.g.: universities, academies, scientific societies, etc.).

## 6. Structured outline of the number of employees and volunteers in your organisation who work on talent support and related activities.

- Professional background, as well as documented work of volunteers and/or employees maximum of 20 points.
- The scoring will focus on: the number of part and full time employees and their professional background.

**7. Support of at least 5 national or international contacts (potential collaborations, organisations, potential European Talent Centres or potential European Talent Points e.g. schools, organisations of gifted education) representing at least 5 geographically distinct locations**

- Evidence of joint activity between applicant and listed contact maximum of 10 points

**8. Presence of an international Advisory Board or Board of Trustees that you must report to on a regular basis**

- Professional background, expertise, as well as international recognition of Advisory Board members or the intention of forming an Advisory Board maximum of 10 points.

**9. Description of your future plans in essential and in desirable activity areas**

- Well documented activity, efficiency, professional level in gifted education or in talent support,
- high-profile plans of future cooperation in European talent support will be scored by a maximum of 20 points.

**10. A brief summary indicating how your centre has the financial means to meet the essential requirements** maximum of 10 points.

**11. What can you offer to the forming of a European Talent Support Network?**
